## **Keynote Presentation by Dr. David R. Hopkins**

Dr. David R. Hopkins has served Wright State University since 2003, first as provost and currently as president since 2007. Formerly, he served Indiana State University in several leadership roles including interim provost, senior associate vice president, interim dean of the School of Business, and chair in the Department of Physical Education. Dr. Hopkins is nationally recognized for his leadership and continues to serve on a variety of local, state, and national boards and coalitions.

A central theme to his administration at Wright State has been the creation of a culture for innovation throughout the university that is reflected through the development of several Centers of Excellence. Six of these multidisciplinary units have been designated Ohio Centers of Excellence by the state and reflect a commitment to technology-based economic development by attracting and retaining national researchers, educators, artists, students, and investments to produce a quality of life conducive to future growth that will transform our region.
