3 CALL TO ORDER

3 Call to Order

The Indiana State University Board of Trustees met in regular session at 2:00 p.m. on Friday, October 4, 2013 in the State Room, Tirey Hall.

Trustees present: Mr. Baesler, Ms. Bell, Mr. Lowery, Mr. Minas, Mr. Pease, Mr. Pillow, Ms. Sluyter and Mr. Taylor. Trustee absent: Mr. Campbell.

President Bradley, Vice Presidents Beacon, McKee, Tillery and Williams and Ms. Sacopulos, General Counsel and Secretary of the University were present. Also attending were Dr. Steve Lamb, Chairperson of the Faculty Senate, Ms. Karen Buchholz, Chairperson of the Staff Council and Mr. Logan Valentine, President of the Student Government Association.

There being a quorum present, Mr. Minas called the meeting to order at 2:05 p.m.

REPORT OF THE FACULTY SENATE CHAIRPERSON (Dr. Lamb)
(Dr. Lamb submitted the following report)

You know the following. Our President, under the leadership of several different Trustee Chairs has increased the enrollment dramatically. He has demanded creation of a viable College of Nursing, Health and Human Services with a healthy number of new successful programs. He has instituted a viable strategic plan. He has successfully revitalized a faculty performance review process. He has hired an outside consultant firm to provide needed invasive guidance to our students. He has created a University College that coupled with the efforts of all stake holders is increasing retention despite the dramatic change in average SAT scores, a most remarkable achievement.

The Deans are passing his message of recruitment and retention down to the departments. If he gives that message one more time, I will be afraid for his sanity. Each department is developing action steps to emphasize the importance of both under the guidance of the Student Success Office. Please understand that faculty already devote their lives to retention. All of us employ every bit of knowledge that we have to enable our students to grasp the content of our respective disciplines. This is what we live for.

Since arriving in 2008, Dr. Bradley has been a tireless administrator. Enrollment is 18% higher than when he arrived. Though tuition is up 18.6%, tuition revenue is up 36%, because of those healthy enrollments. The revenue from the dorms is up nearly 40%. All the while he has managed to have operating expenses rise only 10%. His tight management has allowed us to absorb an 11% appropriation cut. The institution's "profit", that is the net increase in assets year to year has also risen 42% since 2008.

Again, where is the problem? I greatly enjoyed the message given to the entire community by Trustee Baesler at the fall address of the President. He seems to have a solid understanding of the pressure that the University and that departments are under. By the way, the President did a superior job of tying the retention and recruitment rates to the health of the institution via his spreadsheets. Somehow, when his picture is hung on the wall, we need to have a spreadsheet in the background.

The faculty have accepted the President's leadership. He is performing quite well. His success should have garnered him the privilege of steering his own course. It has from the faculty perspective. Of course, much of that respect given to him is due to his attitude towards the campus community.

Ok, another message for you to ferret out. As you may know, I am chairperson of a department within the Scott College of Business. Only one other individual on campus has been a chair longer than I, and I serve at the pleasure of the Dean, and I have had ten of those (6 of them while I have been chair of the department). I would like you to understand that my faculty are mobile. They get offers on a monthly basis. This is not at all unusual for tenure/track faculty in a great number of disciplines. I have a good record of retaining faculty. I am successful, because I understand their value, and their marketability. They have options. And the most successful teachers have the most options. They have reams of data, proving their value in the classroom. After all, they are employed at an institution that highly values teaching expertise, and our faculty have great challenges in the classroom that they have successfully met. Also a great number have solid research records.

Regardless, they have accepted every challenge put their way. Students are rarely if ever turned away from a classroom. While enrollments have greatly increased, the number of faculty has not. We are doing much more without any proportional increase. SCH's are increasing, and that is appreciated and necessary. That is understood. That challenge has been uniformly graciously accepted. New pedagogical techniques are being aggressively explored. Our goal is to transform these students into graduates that can contribute effectively to society.

I plead with all to respect the character of the institution, and to respect the enormous effects that are currently being made to continue to recruit and retain our student body, to provide our students with a quality education that all of us can take enormous pride in. We are dealing with challenging students, and we are effectively challenging those students to become quality citizens.

REPORT OF THE STAFF COUNCIL CHAIRPERSON (Ms. Buchholz)

REPORT OF THE STUDENT GOVERNMENT ASSOCIATION PRESIDENT (Mr. Valentine)

(Mr. Valentine submitted the following report)

Homecoming is upon us and it has been a very busy time of the year for all departments. The past month has gone very well for Student Government, though I will confess that there have been the usual road blocks along the way. Amidst the small bumps in the road we have completed a few of our larger projects and are very close to completing others as well as bringing new discussions to the senate.

All 35 senate seats are now occupied and you can sense a difference in the atmosphere at the formal senate meetings than there was before. As the senators, new and old are continuing to learn things such as parliamentary procedure and that they need to be able to be the voice for the other 12,000 students at Indiana State, ideas are being formulated much faster and discussions are quickly becoming much more interesting. It is exciting that so many new ideas are coming to the table from campus life to updating the constitution and code. The selection of the judicial branch is ahead of schedule as I had planned to take appointments to senate by the end of this month. However, it seems that I will be able to have them from the judicial selection commission much sooner than that. In the past two weeks we have met with the Chief of Police Bill Mercier and the Director of Student Conduct and Integrity Craig Enyeart on our medical amnesty bill which aligns with the Indiana Life Line Law which we hope to take to the faculty senate soon. In the next month we hope to start much discussion on the topic of grade reporting regarding the timeline in which grades will be given back to students and how to do so. After speaking with various administrators we are hoping to have grades reported back to students in a timely manner through blackboard. We know that we will have to work closely with faculty to get this done and we intend for none of it to require Dr. Lamb to fill out any reports.

It is a large personal goal of mine for students to know their grades as early as possible so that they may seek out tutoring or other methods of help earlier in the semester which should help increase those students' grades. Our Director of Academic Affairs, Audrey Nichols has been working with Rich Toomey and Admissions on a new program called "Be a Branch" which will send undergraduate students who have been successful at Indiana State to high schools for recruiting purposes. They are hoping to have 20-30 students go through a selective process with requirements such as a high GPA so that they can have the opportunity to give back to their school. The intention is to show potential incoming students how much Indiana State can do for them by hearing a story from a current student that they may be able to relate to. SGA wants to help as much as possible with the recruitment, retention, and success of our students.

The Forest is now at nearly 800 members, over 200 more than this time last month and we expect that the student section will be in full force at the game tomorrow. The Forest members got together to walk in the torchlight parade on Wednesday night and will be walking in the parade tomorrow morning as well. The Sycamore Leadership Coalition is

underway as 23 members have been accepted into the freshman branch of SGA this year. We plan to get them involved as soon as possible after their initial meeting next week through events such as participating in the Fall Student Success Conference where many SGA members will be facilitating conversation and discussion after Dr. Ken Bain's keynote speech. Our proposal for a break out session at the conference has also been accepted. In our breakout session we intend to provide the input on how the students themselves believe that their professors make the biggest impact on them in the classroom.

With homecoming ending after this week, we will have more time to focus on the smaller things that SGA can do for the future of the student body and in order to develop a positive action we must first develop a positive vision. I intend for Student Government to develop that vision and take pride in everything that we do. I hope to see everyone at the game against Youngstown State tomorrow and operation 10k against North Dakota State on October 26.

REPORT OF THE PRESIDENT OF THE FOUNDATION (Mr. Carpenter)
(Mr. Carpenter made the following comments)

The Foundation Board met this morning. We had a clean audit for 2013 and came out with a balanced budget. It is a good sign for us in the coming year.

The Distinguished Alumni reception and program will be held this evening. We are expecting about 350 people to attend. Four distinguished alumni will be recognized. We are always excited about this time of year. The Distinguished Alumni will be recognized at the football game and parade tomorrow.

The Larry Bird statue dedication will be held on November 9. For the dinner with five weeks to go, 81 tables have been sold out of 100. That is pretty good at this time. We are planning a wonderful evening and have tickets for sale for the program. The statue will be unveiled at the Pacers game on October 29. This will be great for the artist and for ISU. If anything this will add to the event and excitement. We are hoping for alumni to attend the Pacers game.

The Athletics Hall of Fame event was held on Thursday evening. Five individuals were inducted in to the Hall of Fame. I was pleased to see President Landini being honored for his support of the University and athletics. He was my President when I was here. He was the number one fan. His induction in to the Hall of Fame in his memory was an opportunity to acknowledge him for his accomplishments and support of the University and athletics.

I have attended homecoming for many years, and played in four homecoming football games. We do not want to lose homecoming. It is so exciting not only for the team but also the crowd. Athletes will play hard and I hope you all come out and watch the game.

REPORT OF THE PRESIDENT OF THE UNIVERSITY (Dr. Bradley)
(Dr. Bradley submitted the following report)

I am pleased to report that more than 1,000 employees have completed the online questionnaire and signed up for biometric testing as part of our new wellness initiative.

The testing includes height, weight, body mass index, blood glucose, and cholesterol. Employees receive their results within a few minutes and have the opportunity to discuss them with a health professional. The program is designed to make employees more aware of their health status and to identify potential future risks. By participating, employees will receive a \$30 per month discount on their health benefits costs. It is great to see so many individuals taking part in this optional program, and it will be interesting to see the impact the program will have on our employees' health in the long run. It should also help the University control health benefits costs in the future. The proposed rates for 2014 will include the

wellness incentive and a \$50 per month surcharge for tobacco users. We will be bringing the rates to the Board for approval at your December meeting. This is a new era in health benefits, and Indiana State is committed to continuing a comprehensive wellness program in the future.

In response to the Board's charge to develop specific goals, benchmarks, and initiatives within each academic department, a 13-member Department Success Task Force has been appointed that will be co-chaired by Provost Williams and Virgil Sheets. The task force will begin its work immediately. I look forward to working together to continue to advance our overall progress toward our strategic goals. The Board will hear more about this issue as the work of the Task Force progresses.

Indiana's public higher education institutions are required by Public Law 167 to form a diversity committee. The committee is charged with producing an annual report to the Board of Trustees. At Indiana State, the Board designated the President's Council on Diversity as its diversity committee.

Today, the co-chairs of the Council will present a brief overview of the 2012-2013 report. The co-chairs are Dr. Elonda Ervin, our Chief Diversity Officer and Kandace Hinton, Associate Professor of Educational Leadership. Also participating will be Bonita McGee, Director of Equal Opportunity and Christopher Childs, a member of the Council and Research Analyst in the Center for Student Success. The group made a power point presentation on the report and the work of the Council, and a brief update on discrimination/harassment complaints.

Thank you, Elonda, Kandace, Bonita and Christopher. It is encouraging to see the accomplishments occurring across the University in regards to diversity. Please extend my appreciation to the entire Council.

It has been another exciting Homecoming week with much more to come. The students have been turning out in droves for the week's many activities, and I must say Sycamore Sync was particularly entertaining this year. Our Student Affairs staff, the Homecoming committee, the Alumni Association, the Foundation, the Greek community, our facilities staff and many others all work tremendously hard to make this week memorable and quite enjoyable.

Later this afternoon, the 51st running of the Sycamore Tricycle Derby will take place. Co-founder of the race Michael Simmons will be here to help start the race. Tonight we will honor our Distinguished Alumni including Trustee George Pillow. Congratulations, George on this well-deserved honor.

Tomorrow morning it's the Blue and White Parade followed by tent city. Provost Williams has instituted a competition between the colleges for having the most spirited presence at tent city. I have not personally seen the criteria on which he will base his decision but I hear that food and brown-nosing will be involved. It should be a good time. And, of course, we will be cheering on the Sycamores in their afternoon game against Youngstown State.

REPORT OF THE PRESIDENT OF THE BOARD (Mr. Minas)
(Mr. Minas submitted the following report)

I would like to express my appreciation to Trustee Bob Baesler for representing the Board at the recent Employee Recognition Awards program and President Bradley's fall address last week. Thank you, Bob.

I am pleased to hear about the formation of the Department Success Task Force. I would like to thank the Faculty Senate leadership along with Provost Williams and President Bradley for moving quickly on this issue. I look forward to hearing the results of the group's work and to seeing the impact it will have on advancing our goals.

Homecoming is always one of the best times of the year, and Indiana State does it extremely well. I would like to congratulate George Pillow on being named one of this year's Distinguished Alumni Award recipients and also extend congratulations to the McKee family on Craig's selection for this honor. We will be honoring them along with Danny Tanoos and Sara Wheeler tonight, and they will also participate in the parade and half-time festivities tomorrow. I would also like to congratulate Provost Emeritus Jack Maynard on his selection as grand marshal for this year's parade.

I am glad to hear that employees are taking advantage of the wellness program. This is a move in the right direction and will result in a healthier workforce over time. It also will help the university meet the goal of keeping the increases in our health insurance costs under control.

Today's agenda includes the new staff salary schedule that incorporates a 2 percent across the board increase in compensation for all full-time employees with good performance. Faculty who meet expectations will also receive the increase. These raises are made possible by everyone's efforts to increase enrollment and improve retention and by the thoughtful budget management led by President Bradley and Vice President McKee. On behalf of the entire Board of Trustees, I would like to thank our faculty and staff for their dedicated work.

According to responses regarding the date for the Board Retreat, it seems that June would be a good time. It is not locked in but that is what we are looking at.

5c DONATION OF REAL ESTATE

The Sherwin-Williams Company has expressed interest in the donation of real estate located at 180 Canal Street in Terre Haute, Indiana to Indiana State University. The site consists of approximately 2.66 acres with

existing buildings and other improvements. The proposed donation is subject to the following terms and conditions:

1. **Donee:** Indiana State University
2. **Property:** Those certain tracts or parcels of land commonly known as the MAB manufacturing facility, located at 180 Canal Street, Terre Haute, Indiana 47803, containing approximately 2.66 acres, more or less, situated in the City of Terre Haute, Vigo County, Indiana, together with the existing buildings, parking areas and all other existing improvements thereon (the "Property").
3. **Examination Period:** Donee would have a period of sixty (60) days after the execution of the Donation Agreement ("Examination Period") to conduct, at Donee's sole expense, whatever reasonable investigation, analysis and studies of the Property that Donee deems appropriate, including, but not limited to, an environmental site assessment, investigation of zoning, title matters and size and condition of the Property and improvements. In the event Donee is not satisfied with the results of any of the above examinations and inspections, then Donee would be allowed to terminate the Donation Agreement by providing written notice thereof to Donor prior to the expiration of the Examination Period. In the event that Donee were to fail to so notify Donor of its intent to terminate prior to the expiration of the Examination Period, it would be deemed to have waived its right to terminate thereunder.
4. **Fair Market Value and Appraisal:** On or before January 15, 2014, Donor would obtain an appraisal of the Property from a certified real estate appraiser (the "Appraisal"). In the event that the fair market value of the Property as set forth in the Appraisal is less than \$750,000.00, Donor would have the right to terminate the Donation Agreement by providing written notice thereof to Donee within fifteen (15) days thereafter. If the Donation Agreement was not terminated as set forth above, then the fair market value of the Property as set forth in the Appraisal would be deemed the value of the donation, it being understood and agreed that Donor intends to claim a charitable deduction for this donation as a charitable contribution to a qualified recipient organization under the provisions of Section 170(c) of the Internal Revenue Code and regulations thereunder, and corresponding state statutes, for the year in which the Closing occurs.
5. **Qualified Recipient:** Donee would represent that it is a qualified recipient organization pursuant to Section 170(c) of the Internal Revenue Code and regulations thereunder. The Donation Agreement would provide that Donee would cooperate with Donor in order to permit Donor to claim a deduction for a charitable contribution, and to provide Donor with such documentation as Donor may reasonably request relating thereto, including Donee's status as a qualified recipient organization under Section 170(c) of the Internal Revenue Code.
6. **As-Is Donation and Condition of Property:** The Property would be donated on an "AS-IS, WHERE-IS, WITH ALL FAULTS" basis and without any representations, warranties or indemnities. Donee acknowledges that Donor may drain the pipes and turn off the heat to the Property prior to the date of Closing. Donee shall satisfy itself during the above described Examination Period with respect to all conditions affecting the Property.
7. **Transfer of Title:** The conveyance of the Property would be by Quit Claim Deed, subject to all easements, covenants, conditions, restrictions or other matters of record.

8. **Closing:** The date for delivery of the deed and closing of the transaction would be on or before February 28, 2014.
9. **Closing Costs and Perorations:** Donor would be responsible for paying its proportionate share of the real estate taxes and assessments up to the date of Closing. Donor would pay all utility charges for the Property up to the date of Closing. Donee would pay for the cost of all surveys, inspections, studies, tests, title examinations, any policies of title insurance or endorsements, and recording of the deed.
10. **Restriction on Sale or Transfer:** The Donation Agreement and Quit Claim Deed would contain a restriction that prohibits the Donee from selling or transferring the Property for a period of three (3) years following the date of Closing. The above restriction would be considered by the appraiser in determining the fair market value of the Property in the Appraisal.

The parties understand and intend that: (i) this is only a proposal and shall not be construed as a commitment, representation or legally enforceable contract against either party, even after acceptance; (ii) no cause of action shall arise from this proposal or be based thereon; (iii) upon acceptance of this proposal, both parties shall exercise their best efforts to negotiate and execute a definitive agreement for this transaction; and (iv) until a definitive agreement is entered into, neither party shall be under any obligation to the other regardless of this proposal or of any negotiation(s), agreement(s) or undertaking(s) between, or action taken by, the parties with respect to this proposal and/or the transaction contemplated hereby.

Recommendation: Authorization of the Treasurer of the University to sign on behalf of the Indiana State University Board of Trustees a non-binding letter of intent to donate real estate located at 180 Canal Street in Terre Haute, Indiana containing the terms shown above and to negotiate and sign a mutually acceptable Agreement to Donate Real Estate (Donation Agreement). The Treasurer of the University is further authorized to sign all closing documents related to the transfer of real estate should the donation be mutually acceptable to both parties.

On a motion by Mr. Pease, seconded by Mr. Lowery, the recommendation was approved.
